Rules & Regulations



A. Eligibility

Junior : Solo (Without distinction between male and female)

15 ~ 18 years old (born between September 10, 1998 ~ September 9, 2002)

*Participants must prepare Choreography for the competition, not to exceed 4 minutes.

Senior : Solo (Male / Female)

19 ~ 34 years old (Born between September 10, 1982 ~ September 9, 1998)

*Participants must prepare Choreography for the competition, not to exceed 4 minutes.

B. Categories

■ KIMDC Junior Division

Round I : KIMDC Semi-final

Performance of the choreography you prepared, not to exceed 4 minutes.

Round II: KIMDC Final

- 1) Performance of the choreography you prepared, not to exceed 4 minutes.
- 2) Performance of the choreography which is given by KIMDC (within 2 minutes).

■ KIMDC Senior Division

Round I : KIMDC Semi-final

Performance of the choreography you prepared, not to exceed 4 minutes.

Round II: KIMDC Final

- 1) Performance of the choreography you prepared, not to exceed 4 minutes.
- 2) Performance of a piece which is based on a choreography given by KIMDC (within 2 minutes).

*KIMDC will send the given piece to KIMDC participants by email after application.

C. Application Process

Registration Period for international participants

From May 8(Mon) to May 26(Tue), 2017

(participants must be sent no later than the deadline to KIMDC)

4) Video Files(MP4) or links on Youtube, Your Solo Dance Work (within 2 minutes)

D. Selection Process (Video for International Participants)

-KIMDC will contact the selected international participants individually by June 15, 2017.

-International participants must pay KRW 200,000 application fee after accepted by KIMDC via video .

E. Special Clauses

Participants who received an award (prior to July 2016) for International Dance Competitions which are authorized by Korea Military Manpower Administration will advance directly to the Semi-Final. Participants MUST prove by sending the certificate of award. However, all who participated once as a prize winner of the competitions in previous KIMDC are not allowed to go directly to the semi-final.

G. Rules

1) Stage

- The order of appearance on stage is determined by drawing number.
- All participants must attend in the opening ceremony in order to draw numbers which is held before the opening ceremony (**September, 9, 2017**)
- All Participants is responsible for their own costumes and make-up.
- Performance in the nude is not allowed
- Lighting systems are assigned by the organization but it is usable. (no spotlighting and only white lighting)
- The costumes for performance given by KIMDC : black leotard & black tights / no matter of the shape.
- The stage's Sise is 22m(Width) x 18m(depth) x 11m(hight).

2) Props

- All participants can use their own props.



- But all props of participants must not damage the stage and disturb other dancers also.
- All of risk element(like all sorts of confetti, liquid and pyrophoric material) are not allowed.

3) Music

- Participants must submit their own musical material.
- Participants must send a music file(MP3, WAV) that you intend to use for this competition by e-mail(koreaimdc@gmail.com) and bring additional recording CDs and USBs.
- The music file and recording CD must be marked with the participant`s name and a title of your pieces.
- Participants are responsible for the quality of the music.
- Participants must bring additional music files or recording CDs for rehearsals.
- Participants must bring your own musical instruments your own expense if needed.
- Each participant must take the responsibilities for copyrights of your chosen music.

4)Travel

- Round trip expenses for flight(Seoul to participants` destination)are the responsibilities of the participant.
- International participants must submit flight information for each participant during August 30, KIMDC.
- Participants must arrive at Cheon-an(destination) by themselves.
- Transportation between the airport and accommodation on the arrival day for the participants, your coaches or competing partners is the responsibilities of the participant.
- KIMDC committee provide transport to participants from hotel to 2017 KIMDC orientation.

5)Housing

- The committee provide only accommodation to participants during 2017 KIMDC.
- All participants will stay at the hotel, "Tedin Family Resort". KIMDC provide information about the hotel and location by email and KIMDC homepage.
- Hotel and food for coaches and family members are the responsibilities of the participant.
- The committee will assist participants in getting accommodation reservations at a reduced rate.

6)Insurance

Applicants are responsible for your own medical and travel insurance coverage (accident, hospitalization, medical expenses and etc.) during KIMDC period in Korea.

7)Arrival Date & Orientation

- International participants must arrive and check in the hotel by 5pm, September 7(Fri), 2017.
- All participants of semi-final and final competition must meet the requirements in order to draw numbers or orientation.
- After semi-final competition, if the committee require additional orientation participants in final competition must accept a request.

8)Rehearsal



KIMDC provides an opportunity of rehearsal to participants before the competition starts.

9 Rights and Copyright

- All participants must participate in all the events or performances as organized by the Committee during the period of the Competition.
- KIMDC reserves all rights for TV broadcasting, videotaping and filming and interviewing with mass media during all competition presentations, the Awards performance and a Gala Performance, as well as for the manufacturing and merchandising of video cassettes containing the same, with no payment of fees to the participants, of the competition.
- The organizing committee also reserves the exclusive right to sign contracts with third parties for merchandising of the above-mentioned material.
- Every filming, photographing and videotaping needs approval with KIMDC organizer before the competition starts.
- All dancers winning awards must appear in the gala performance with the work nominated by the Jury.
- Participants will not be paid for your appearances in the events during the competition.
- For appearances in events that are not part of the official competition schedule, participants may receive payment for your appearance only if permission has been procured in advance from the KIMDC Committee.

10) Judging Committee

- From now on, the Judges will be conformed on, behalf of selected countries' notable dancing introduction by the 2017 KIMDC committee.
- The Judges are not obligated to present an award if there are no qualifiers.
- The participants cannot object to the judges and 2017 KIMDC committee's decision.

11) Other Important Informations

- The other of the contest will be determined by the raffles of all participants of the orientation.
- For finalists, the order will be determined by the semi-final list's contest order result.
- All contests will be Public. (However, foreigners' audition is private for their video evaluations.)
- The award recipients are responsible for the public charge and tax of the prize money.
